4)Action Item Approve Financial Reports thru December 2023	Shari began sharing her screen KONO bank balance-\$268,607.14 CD-\$75,000 Total-\$343,607.14 Total Revenue-\$689,019.53 Total expenditures-\$727,716.63 Net loss-\$38,697.10 Shari stated that KONO was under budget because approximately \$130k was added to the budget from the carry forward. The net loss is only looking at income vs expense and not the 2023 budget. First Friday bank balance- \$80,592.21 Total income-\$312,264.00	Action: Financial Reports approved thru December 2023

5) Action Item: Renew 6 month CD	Shari stated that the CD that is holding \$75k at Bridgebank is up for renewal on Jan 24th and she requested that we renew the CD into the 5% interest rate CD again. Joseph suggested that Shari find the 1 year rate, email that info to the committee and it will be decided on. Alan motioned to approve renewal Nick motioned to renew CD Mike-opposed Motion passed	Action: Approved Renew CD on January 24, 2024
6)Discussion: Discussion: Crime Impact Survey Results & Policy change requests	Shari-started sharing her screen and mentioned that the survey revealed that most of the business owners that responded also lived in Oakland, and restaurants and cafes were the highest demographic with 136 people completing the survey. Shari also mentioned that we could pull out the stats only pertinent to KONO to see if our district has higher or lower crime statistics compared to the city. Shari stated the biggest takeaways from the survey is the lack of the business owners reporting crimes due to them feeling it's a waste of time and nothing gets done and that a high percentage of businesses are considering closing or moving to a new location outside of Oakland. Shari stated that she has already reviewed the survey with councilmember Fife and is setting up a meeting with the mayor's office. Shari concluded that KONO should create a campaign to promote the need for reporting all crimes as it helps to confirm the dire situation the city is in and impacts distribution of resources. Shari also went over the list of changes the BID Alliance came up with that is being requested. Alan stated that there is a separate abandoned car hotline Nick stated that we need extremely clear messaging advising the community on who to call when there's abandoned vehicles or see different crimes being committed and have a designated intern for KONO just for marketing the messaging to the community.
